- A candidate must score at least 27 or more points on the CUT scoring scale for the National Senior Certificate (NSC) examination.
- Subject requirements as per course.
- You may apply with your Grade 12 June examination marks.

International Students

All Foreign nationals who are interested to study at CUT and are in possession of a foreign tertiary qualification must be evaluated by the South African Qualifications Authority (SAQA) <u>saqainfo@saqa.org.za</u> or <u>www.saqa.org.za</u>.
