RESEARCH ETHICS AND INTEGRITY AT CUT

Central University of Technology (CUT) is committed to the core values of customer service, integrity, diversity, innovation and excellence. As part of the core values it is important for the university to promote responsible conduct of research in line with internationally acceptable norms and standards.

The Research Ethics and Integrity Policy Framework was approved in 2016. It was recently reviewed, and the updated framework will be available after the approval by Senate in 2021.

FUTURE PLANS: DEVELOPMENT OF AN ACCREDITED HUMAN RESEARCH ETHICS COMMITTEE

The Research Development and Postgraduate Studies section is currently in the process of developing an Accredited Human Research Ethics Committee for the University. The update of the progress with the establishment of this envisaged Committee will be communicated on the University's webpage.

ETHICS TRAINING

A) Graduate School Webinar Series on Research Ethics and Integrity in Academic and Scientific Writing

The Graduate School hosted a series of three webinars on some key concerns relevant to research ethics and integrity in academic and scientific writing, including plagiarism and the use of Turnitin.

The webinars, focused on research ethics and integrity challenges in academic and scientific writing, as well as understanding what plagiarism is and how to avoid it. Examples on how to apply writing strategies and skills to avoid inadvertent plagiarism in academic texts, were discussed.

On 19 August 2020 Webinar 1 was presented on the theme: Research ethics and integrity challenges in academic and scientific writing. Prof. Laetus OK Lategan gave an overview of research ethics and integrity challenges. Dr Johan Badenhorst presented a live illustration of the Turnitin software and Ms. Cecilé Olivier presented examples to explain the interpretation of results.

Webinar 2, on 26 August 2020 addressed the application of writing strategies and skills to avoid inadvertent plagiarism in academic texts. The presenter, Dr Alet Olivier, illustrated practical examples on paraphrasing, a comparison between longer source text, word-for-word plagiarism, patch-writing

The application of the Originality Report of Turnitin.com and the formative value of Turnitin.com for students were discussed as well as voiceless writing and writing with voice – positioning your voice in finding your writing identity by means of your personalised and socialised voice.

Webinar 3 focused on the nuances of plagiarism and teaching through metaphors how to avoid plagiarism. Dr Olivier discussed ethical research and why society disapproves of plagiarists. Reality and prevalence of plagiarism were also debated. The audience was engaged with insightful metaphors for avoiding plagiarism such as cheating (intentional plagiarism), cloning (verbatim use of a source text), 2nd hand clothes (how much 'common knowledge' can be reused) and your gang or support team, which relates to the need to incorporate research and the call on authority.

The presenters highlighted the fact that plagiarism prevention lies in specific instruction as to what plagiarism entails in academe; the shifting of the focus towards better academic writing; applying the principle of text transformation; applying your "own voice" versus "voiceless writing"; teaching writing as a process, namely a process of prewriting, drafting, revising and editing.

B) SARIMA Workshop: Research Ethics Committee Fundamentals

SARIMA hosted a two-day workshop (3 hours per session) that guided delegates through the fundamental aspects of setting-up and running a research ethics committee (REC). The workshop covered a number of pertinent and current topics including the history and principles of research ethics, regulatory requirements and framework to register a REC, governance and the responsibilities of REC, membership and training requirements, social media in research, confidentiality, privacy, informed consent, gatekeeping, authorship and conflict of interest.



A total number of seven (7) colleagues have attended the workshop. Colleagues should have completed two quizzes and the evaluation form at the end of the two-day workshop, upon which attendees did receive a certificate of participation.
