- 3.1 The lessor shall be entitled, at any time during the currency of this rental agreement; to adjust the rental by giving 1 (one)-calendar month's written notice to the lessee.
- 3.2 The lessee may not cede, assign or sublet, or permit anyone to occupy, the rented premises/room or any part of it without the lessor's prior written consent. The lessee may under no circumstances take in any person or persons on the premises as paying guests or lodgers without the prior written consent of the lessor and may not allow the premises to become overcrowded.
- 3.3 Should the lessee fail to pay any amount owing in terms of this rental agreement on the due date thereof, or commit any breach of any of the terms of this agreement, the lessor shall be entitled to cancel this contract forthwith without prejudice to any other claim that the lessor may have against the lessee.
- 3.4 No variation of this rental agreement, or the mutually agreed cancellation thereof, shall be of any force or effect unless it is in writing and is signed by or on behalf of the lessor and the lessee.
- 4. The lessor acknowledges that the Central University of Technology, Free State is not a party to this agreement and that the lessee is personally liable for the payment of the rent according to the contents of this contract. As such, the University shall not be liable to the lessor or lessee in terms of this agreement. Nor shall the CUT be bound by any warranties, representations, undertakings or similar assumptions, either express or implied, made by its officers, employees or students purporting to fix the CUT with any liability directly or indirectly related to this agreement.
- 5. This rental shall be terminable by either the lessor or the lessee upon one month's notice in writing, provided that such notice must be given at or before noon on the first day of the month at the end of which the rental is to expire.
- 6. The lessor chooses his/her *domicilium citandi et executandi*, while that of the lessee shall be the address of the premises.
